The second page of your citation under "There are Two Ways to Contest Your Violation" says to go to web site www.violationinfo.com where you can allegedly read Wilmington's law Sec. 5-46.3 and download your Affidavit of Non-Responsibility. But www.violatoninfo.com does not quote Sec. 5-46.3. It quotes NCGS 160A-300-1 where you can only transfer responsibility when your car is stolen or sold. And then you have to squeal on the driver. Neither web site nor Verra Mobility correctly quotes Wilmington's 5.46-3. The ordinance uses the word "or". Therefore, 5.46-3 says that you only have to say "I did not give permission to the driver of my car to drive my car at the time and location on the citation." You do NOT have to squeal on the driver.

If Safelight does not accept this affidavit, then go to the Wilmington Police Department.

First make sure you get the name of the person who disallowed the affidavit. Better to get a written signed response from Safelight that it will not accept the affidavit.

If you have a phone conversation with Safelight or got to Safelight's office in person, then record the conversation. (Use a second iPhone.) In North Carolina, as long as you are a party in the conversation, you do not need to ask permission to record the conversation. And you do not even need to tell the other party you are recording the conversation.

Once you have this information, immediately tell the officer-on-duty that you want to press charges against the person, "as an individual", who will not accept the affidavit. Also ask the police officer to shut down the Safelight office.

Safelight already knows about the law because your affidavit states the law. It has no excuse.

The City of Wilmington with Verra Mobility (aka American Traffic Solutions) have willfully committed fraud by limiting your legal options for the purpose of taking your money. A felony: NCGS 14-118.

KEEP A PAPER TRAIL

- 1. Make a copy of your affidavit before mailing it.
- 2. Make a copy of your citation.
- 3. Keep *all* the pages of the citation.
- 4. Mail the affidavit with the copy of your citation using "Delivery Confirmation" to the mayor. You need to have the date the US Post Office mailed the letter.
- 5. Make sure you mail your affidavit to Wilmington within 28 days of your violation.
- 6. Go to http://www.violation.com within 60 days of your violation. Download the full-resolution photos and the video. The written information at the top of the photos is extremely important.
- 7. If Wilmington sends you a Penalty letter, ignore it but keep the letter.
- 8. If Wilmington's collection agency sends you a letter, keep it.
- 9. Scan in all your paperwork and e-mail it to canute@redlightrobber.com. Email the downloaded photos and video too. In your scans, we must be able to read the small print inside the photos on your citation.
