WITNESSETH:


WHEREAS, on August 25, 2009, the parties entered into an Interlocal Agreement, New Hanover County Contract 10-0093, to set forth the terms for County's financial support of a portion of City's Red Light Camera Program ("Agreement"); and

WHEREAS, the parties hereto have mutually agreed to the terms of this Amendment as hereinafter set out.

NOW, THEREFORE, in consideration of the premises and the promised covenants contained in the terms and conditions heretofore set forth, the parties hereto amend the Agreement as provided below.

- Section 4, "Duration" is amended to add the follows:
 This Agreement shall be renewed on September 1, 2013 for an additional twelve-month period, and unless sooner terminated as provided herein, shall continue through August 31, 2014.
- 2. Ongoing Effect. Except as specifically above amended, the original Agreement shall remain unaltered and in full force and effect.

Dear Mayor and Councilmembers:

Attached for your consideration is a resolution to amend the interlocal agreement between the City of Wilmington and New Hanover County for joint operational participation in the SafeLight Automated Red Light Enforcement Program (08TR10). This amendment extends the expiration of the existing agreement for one year ending September 1, 2014. The extension of the expiration date coincides with the most recent extension of the vendor contract for the operation of the Safelight cameras. This will allow the City to assess both the operational contract and the interlocal agreement at the same time, in order to ensure the future continuity of both.

This agreement is consistent with the Safe Community and Civic Partnerships strategic Focus Areas. Failure to pass the resolution will result in the expiration of the existing contract and the potential loss of the up to \$200,000 annual contribution to the red light camera enforcement program by New Hanover County. Passage of the resolution allows for the continuation of County support for this program.

Passage of the attached Resolution is recommended.

Resolution Amending the Interlocal Agreement between the City of Wilmington and New Hanover County Relating to Red Light Cameras (08TR10)

LEGISLATIVE INTENT/PURPOSE:

Pursuant to G.S. 160A-300.l, the City has installed a traffic control photographic system to photograph vehicles running red lights at certain intersections in the City ("Red Light Camera Program").

The City's Red Light Camera Program has been effective in reducing vehicle accidents at intersections with a resulting reduction in property damage and bodily injury.

The Red Light Camera Program has been effective in reducing the demand for law enforcement, public safety and emergency medical resources.

Pursuant to G.S. 115C-437, ninety percent (90%) of the amount of civil penalties collected from citations issued under the Red Light Camera Program is paid to the New Hanover County Board of Education.

The County is authorized by G.S. 153A-212 to cooperate with other local governments in law enforcement matters, and to amend the interlocal agreement with the City related thereto is permitted by G.S. Chapter 160A, Article 20, Part 1.

THEREFORE, BE IT RESOLVED:

THAT, the City is hereby authorized to amend the interlocal agreement with New Hanover County relating to the Red Light Camera Program in accordance with the above terms and conditions.
