2. Your Right to View Video

- 3. You Must Select One of the Following Options A, B, or C.
 - A. Pay the fine. As the registered owner of the vehicle described in this Notice, you are responsible for this violation and are responsible for paying this fine by: 05/21/2012, the clear proceeds of which go to our public school system. No points will be assessed to your driving record, and no record of this violation will be sent to your insurance company or the Division of Motor Vehicles. Of course, if you were not the driver at the time of the offense, you may choose to complete an affidavit as described in Option B, or use the mail-in coupon affidavit on page 2 of this Notice. To pay the fine:
 - 1. Complete the coupon on page 2 for Option A and return the coupon in the enclosed envelope. Make sure the mailing address on the reverse side of the coupon appears in the window of the enclosed envelope.
 - 2. Please do not send cash.
 - 3. Payments by Personal Check, Money Order or Visa/MasterCard are accepted.
 - 4. Make Check or Money Order payable to "Safelight Cary".
 - 5. A \$25.00 service fee will be assessed for rejected or declined payments.
 - 6. Credit Card payments can also be made online at: https://www.photonotice.com (Enter city code: CNC)
 - **B.** Complete an Affidavit of Non-Responsibility. As the owner of the vehicle, you are responsible for this violation unless you can furnish evidence that the vehicle was, at the time of the violation, in the care, custody, or control of another person. The owner of the vehicle shall not be responsible for the violation if the owner of the vehicle, within 30 days after receiving notification of the violation, furnishes the office of the mayor of the Town of Cary any of the following:
 - An affidavit stating the name and address of the person or company who had the care, custody, and control of the vehicle.
 - 2. An affidavit stating that the vehicle involved was, at the time, stolen. The affidavit must be supported with evidence that supports the affidavit, including insurance or police report information.
 - 3. An affidavit stating that the person who received the citation is not the owner or driver of the vehicle, or that the person who received the citation was not driving a vehicle at the time and location designated in the citation.

Included with this Notice of Violation is an Affidavit of Non-Responsibility (Option B of the mail-in coupon on page 2). You may use this Affidavit and the enclosed envelope to satisfy the requirements of Non-Responsibility.

- C. Request a Hearing. You have the right to a hearing before a non-judicial administrative hearing panel:
 - If you choose to have the matter reviewed by the Town's Hearing Board, you must contact <u>THE SAFELIGHT</u> <u>CARY PHOTO VIEWING OFFICE AT 919-388-9129 on or before</u> <u>05/21/2012</u>. At that time, the Photo Viewing Representative will schedule a date and time for you to appear.
 - IF YOU FAIL TO RESPOND TO THIS NOTICE OR REQUEST A HEARING BY 05/21/2012, YOU WILL FORFEIT YOUR RIGHT TO A HEARING.
